



# Privacy Policy

## 1. Introduction

This privacy policy explains how Appago Apps Ltd TA MyLo Ely treats personal information when you create an Account.

- Personal information is information about you that is personally identifiable like your name, email address or phone number.

## 3. App Tracking

3.1 Appago Apps Ltd TA MyLo Ely uses cookies and session management tracking to maintain your user experience. A cookie is a small data file stored on your devices local drive.

3.2 Cookies are required to use Appago Apps Ltd TA MyLo Ely's service.

3.3 The App also uses a 'session cookie' that only exists until you finish your browser session, these cookies are used to store your data as you move through your browser session but are never accessed by anyone else.

#### **4. Storage & Security**

4.2 Your account information is password-protected.
